Williams said he is driven by the fact that health care is always evolving and touches everyone every single day.

Regulations are altered not only in how they are written but also in how they are interpreted, pushing Williams to stay on top of the changes.

"You can use your prior experience and expertise, but you need to be



current and abreast of any changes in the regulatory environment," Williams said. "You need to keep yourself on top of where things may be going in the near future."

His advice for junior attorneys:

Williams encourages younger attorneys to find an area of the law that they love and to pursue it wholeheartedly, with the aim of understanding it better than most.

"By staying on top of the constantly changing environment or field that you're interested in, it's going to serve yourself and the client and help differentiate you from others as you grow in your career," Williams said. "We are always learning and continuing to grow."
