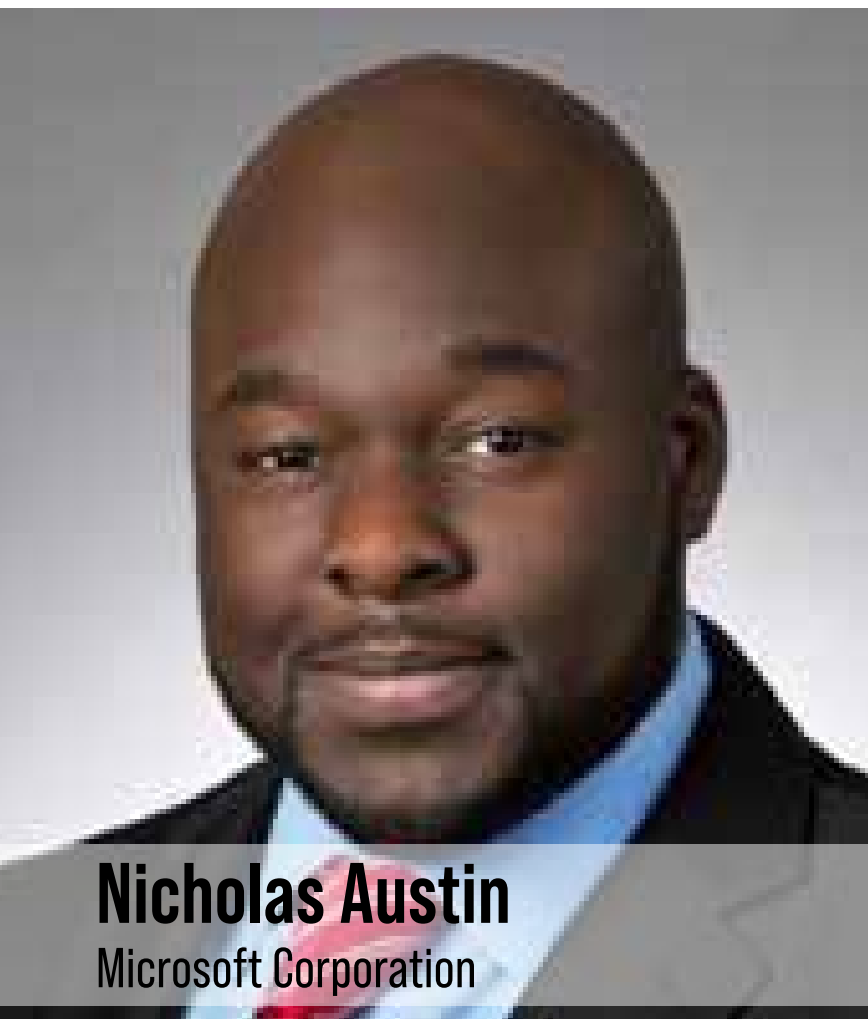

Prior to Wells Fargo, Nick worked as M&A and VC Counsel at Caterpillar, where he advised senior company executives on legal matters pertaining to M&A and Caterpillar’s VC and joint venture projects and as an associate at Foley & Lardner, LLP, Nick handled M&A and business transactions.

Nick works tirelessly to advance diversity in the legal profession. In the last year, he has lent his insight to several organizations and programs, including being a panelist at “Promoting Women and Black Americans in Big and Corporate Law” sponsored by the Greater Washington Area Chapter, Women Lawyers Division, National Bar Association (GWAC) and the National HBCU Pre-Law Summit & Law Expo.

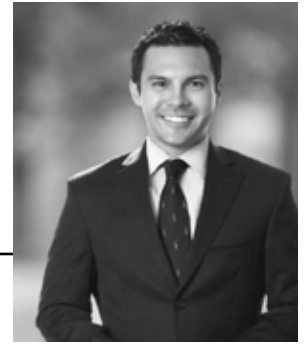

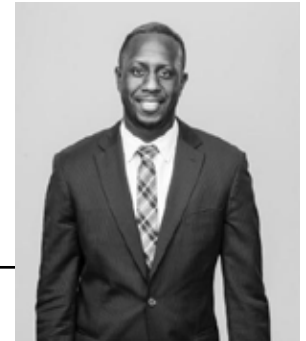

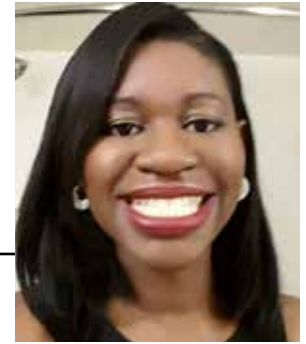
