

### Kirkland Wins an HRC Award for Innovative LGBT Outreach



On March 25th, The Human Rights Campaign (HRC) — the nation's largest advocacy group for LGBT Americans — gave Kirkland and Firm client The Boeing Company the first-ever **"Award for Workplace Equality Innovation."**

The award honors businesses for a specific program that makes a positive difference to LGBT employees. Kirkland

was recognized for its "ALLSA" Initiative, a program that formalizes the Firm's outreach to LGBT, racial/ethnic minority, and women law students by matching Kirkland attorney liaisons with diverse student organizations across the country. Boeing was recognized along with Kirkland for its groundbreaking gender transition program.

Three Kirkland attorneys gave a 20-minute workshop on our ALLSA Initiative. Andrew Nagel, Corporate Partner and Chair of our

LGBT Subcommittee, and Fred Tanne, Corporate Partner and Firm Committee member, accepted the award at a 250-person event held at the Time Warner Center in New York.

Kirkland was also honored, among other companies (many Fortune 500), for receiving a perfect 100 percent score on the HRC's 2009 Corporate Equality Index and Best Places to Work Survey. The Corporate Equality Index is a tool used by the HRC to rate companies on their treatment of LGBT employees,

consumers, and clients. Kirkland received a perfect 100 percent score on this survey in both 2008 and 2009.

### Kirkland Jumps in MLJ Diversity Scorecard Ranking

Kirkland **rose 21 spots to #40 on the 2009 Minority Law Journal (MLJ) Diversity Scorecard** (up from #61 in 2008). Not only does this put us among the top 50 law firms committed to diversity, Kirkland was also ranked #3 on the list of firms with the most racial/ethnic minority partners.

This year, the *MLJ* used a different methodology for ranking firms. In the past, Diversity Scorecard rankings were based solely on the percentage of a firm's minority U.S. attorneys. This year's rankings were determined by adding the firm's percentage of minority U.S. attorneys to the percentage of all minority

U.S. partners, in order to "stress the importance of hiring and promoting minority attorneys to partnership positions."

Diversity Committee Co-Chair Walt Lohmann said, "We are very pleased to be making significant strides in the Scorecard ranking and even more importantly in our

ongoing recruitment and retention efforts." The *MLJ* rankings have a direct impact on the *American Lawyer* A-List rankings, which also take into account a firm's revenue per partner, associate satisfaction, and pro bono.

## LGBT Asylum Pro Bono Project Gains Momentum



Kirkland New York has formalized a firmwide **pro bono asylum project with Immigration Equality**, a national organization which advocates for equality under the immigration law for LGBT and HIV-positive individuals.

Building on the experience of New York IP Associate Joe Loy, who has already won an asylum case for an individual referred to Kirkland through Immigration Equality, and other firmwide efforts in asylum and immigration work, six new pro bono Immigration Equality cases have been staffed—five in

New York and one in Los Angeles.

Individuals referred to Kirkland through Immigration Equality have endured persecution in their home countries that is either inflicted directly by the government, or by other individuals (sometimes their own family) who the government cannot or will not control. These clients have a well-founded fear of future persecution, and an attorney's work on LGBT asylum cases is intensely personal because the outcome can profoundly change the client's life. Cases referred to pro bono attorneys through Immigration Equality have

also helped to shape the developing body of sexual orientation-based asylum law.

The Firm is currently handling six cases seeking asylum for LGBT clients from Ecuador, Mexico, Jamaica, Granada, Ghana, and Colombia. The cases are staffed by five Kirkland partners, seven associates, and interested summer associates. New York Corporate Partner Sue Zachman (pictured here) coordinates the logistics of the project and the ongoing relationship with Immigration Equality.



## Supporting Harvard's Women Alumnae



Kirkland New York was the sole sponsor of the **Third Annual Harvard Law**

**School Women's Law Association Alumnae Conference** that took place February 19th - 21st. The event titled, "From Public Office to Office Politics: Women Navigating in a Political World," explored the unique challenges women face as they seek political

Conference panelists discussed the expectations, pressures, and opportunities that shape the experiences of women lawyers making their lives and careers as elected officials, public servants, corporate officers, and legal counselors. profession.

## Fueling the Diversity Pipeline

On March 15th, Kirkland San Francisco held a one-day onsite career development workshop for high school students as part of their participation in the **National Association for Legal Placement (NALP) and Street Law Diversity Pipeline Program**.

The day consisted of three workshops—a copyright mock trial with witness interviews, mock asylum hearings, and mock negotiations—and students joined Kirkland attorneys for lunch, and participated in a business card exchange later that day. Over 25 Kirkland professionals participated in the program, including partners, associates, staff, and alumni.

Priscilla Fallas, a student from Leadership High School, said she enjoyed visiting a professional law firm and, despite fearing it would be “a boring field trip and a lot of lectures” found the hands-on workshop on contracts to be “very fun and educational.”

The goal of the NALP/Street Law pipeline program is to pair law firms with local diverse and disadvantaged high school students to teach them about substantive areas of the law, the legal profession, and legal career pathways. Kirkland San Francisco is one of five NALP member law firms selected to participate in the pilot pipeline program and the Firm will also contribute \$20,000 to cover program costs. Kirkland attorney

volunteers have already visited three high school classrooms a total of 12 times and presented material related to Copyright, Immigration, and Corporate Law. Participating in the NALP/Street Law program enables Kirkland to demonstrate our commitment to diversity and give back to the communities in which we practice.

NALP is an organization dedicated to facilitating legal career counseling and planning, recruitment and retention, and the professional development of law students and lawyers. Street Law promotes practical, participatory education about law, democracy, and human rights.

## Sponsoring an Important Panel on Same-Sex Marriage

On March 18th, Kirkland D.C. sponsored a **panel presentation on Same-Sex Marriage put on by the George Washington University Law School (GW) chapter of Lambda Law.** The event was part of the Firm's nationally-recognized ALLSA Initiative, a program that formalizes the Firm's outreach to LGBT, racial/ethnic minority, and women law students by matching Kirkland attorneys with diverse student organizations across the country.

Nearly 60 students attended the panel discussion of the

legal, social, and personal implications of current efforts around the country to secure marriage equality for same-sex couples. The panel featured Chris Landau, Head of Kirkland's Appellate Practice, who spoke about his involvement in, and the legal issues surrounding, the California Proposition 8 legal challenge, and Chris Edleson, State Legislative Director at the Human Rights Campaign, who spoke about his work lobbying state legislators nationwide.

David Wilson, a gay rights advocate, also chronicled his journey from being treated as

a stranger by hospital staff when his partner of 13 years died of a heart attack, to being a successful plaintiff in the Goodridge case which secured the right of same-sex couples to marry in the Commonwealth of Massachusetts.

The sponsorship was coordinated by Energy Associate Mike Woods, who serves as the Kirkland Liaison to GW's Lambda Law student group and Andrew Welz, an incoming Kirkland D.C. Summer Associate and president of the GW Lambda Law group.
