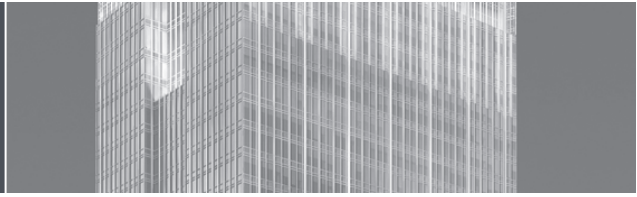

Kirkland Attorneys Advise University of Chicago Students

Kevin Morris, a corporate partner and University of Chicago Law School alumnus, hosted a panel discussion for students from the University of Chicago Black Law Students Association (BLSA) and undergraduate Organization of Black Students (OBS), and the Northwestern University Law School BLSA on May 10. Panelists included corporate partner Louis Hernandez, IP partner Tiffany Cunningham, corporate associate Ketan Shah and IP associate Chanda Rice. The panelists discussed their practice areas and the evolution of their practices through the course of their careers, the law school process and the practice of law relative to the legal education curriculum.

In their discussion of the law school application and matriculation process, the panelists urged undergraduate students to focus on consistently improving their writing skills and preparing for the LSAT early. The panelists also encouraged the students not to become overly stressed with the law school process, and reassured the students that with talent and hard work, each of them will be successful in their own way and their own time. Personally, Morris enjoys participating in these events because it allows him to reflect on his career. Says Morris, “It gives you a good chance to inventory your own development and think about where you are and where you’ve come since law school.”

WLI: Women and Power

Dr. Arin N. Reeves, expert on diversity and women in law, presented to the participants of Kirkland’s Women’s Leadership Initiative (WLI) on March 22. Dr. Reeves’ interactive presentation, “Women and Power: Working with Power to Make it Work for Us,” attracted more than 40 attorneys and filled the house.

Dr. Reeves spoke about identifying, redefining and reclaiming power in the workplace, and the importance of women recognizing and using the power they have to shape their careers. Ferillia Roberson, an IP associate and one of the event’s coordinators, noted that this presentation provided insight into “how we identify power in professional and personal relationships, and recognize from where our power stems.” Another important aspect of Dr. Reeves’ presentation was her emphasis on the power women have to demand change of the status quo to give equal weight to the unique skills traditionally associated with women. Mercedes McFarland, a corporate associate and co-chair of the Chicago WLI Associate Planning Committee, said: “It’s not simply about trying to conform to a standard. It’s about knowing what works best for you in any situation and leveraging your power to get what you need to succeed.”

Team Kirkland weaved through downtown Los Angeles to the Memorial Coliseum, raising funds and awareness to support cutting-edge cancer research for women battling the disease. Associates Sierra Elizabeth (litigation), Erin Kolter (IP), Tanya Jackson (litigation) and Beth Weinstein (litigation), and partner Tana Ryan (corporate), were among the participants.

At the event, survivors of cancer and their supporters wore banners to signify that they fought and beat cancer. Others wore banners to remember a loved one lost to the disease. Ryan was moved to assist the cause by the people surrounding her on that day: "It is amazing when you see how many people among the crowd are wearing banners. It really motivates you to support this great cause when you see the sheer number of people who are affected by the disease, whether as survivors or as someone who has experienced a personal loss to cancer."

ABA Judicial Intern Opportunity Program: A Personal Journey

Each year, the American Bar Association hosts the Judicial Intern Opportunity Program, which places minority law school students in judicial internships around the country. Kirkland's Los Angeles and Washington, D.C. offices co-sponsored this invaluable program, which commenced this year at a reception on June 3 in the chambers of Judge Marshall of the U.S. District Court for the Central District of California.

At the reception, IP partner Denise McKenzie participated on the diversity panel and spoke about patent law. For her, this program has been a very personal experience. In fact, it was the driving factor that brought her to Kirkland. When she first spoke on the panel three years ago, McKenzie was a partner at Sidley Austin LLP. On the panel that year was Kirkland senior IP partner, Bob Krupka. What began as a mentoring program for minority students looking to foray into law became a mentoring opportunity for McKenzie, as Krupka became her friend and mentor.

When McKenzie spoke at the event this June, she had only been with Kirkland for one month, but she jumped at the chance to participate on the panel again. She actively seeks opportunities to mentor and assist minority students who are interested in the law. Says McKenzie: "You need to develop relationships wherever you are and network with people who do things in which you are interested." She cites the importance of networking and making connections. "I did this with Bob, and now they are doing it with me at this program," she added. After the program, she received many emails from students in the audience looking for her to speak at their events and seeking advice. Perhaps a mentoring relationship, like the one McKenzie found through this unique program, will arise for the students who participated in this year's JIOP reception.

Asylum Law with NYU and Columbia OUTLaws

On March 26, nine Kirkland attorneys met with 20 members of the New York University Law School and Columbia Law School OUTLaw organizations for an asylum law training session. The students watched a videotaped training about LGBT-focused asylum law, produced by Victoria Neilson, legal director of Immigration Equality. After the video, the students and attorneys discussed Kirkland's pro bono efforts on behalf of LGBT individuals and organizations. The event concluded with a cocktail reception networking event.

"Our initial focus on the LGBT Asylum cases referred to us by Immigration Equality was borne out of our relationship with students in the Columbia OUTLaws requesting to work alongside Kirkland attorneys on LGBT related pro bono work," says Susan Zachman, corporate partner and coordinator of Kirkland's Firmwide LGBT Asylum Project. "From its formal inception in fall 2008, the project has gained enthusiastic support from the highest levels at Kirkland as a model endeavor, handling in the last year cases involving gay men and lesbians from Ecuador, Mexico, Grenada, Ghana, Colombia and Jamaica, and a transgendered individual from Panama, the first win for Immigration Equality in Panama. We're extremely proud that our work was also honored by Immigration Equality with their 2010 Safe Haven Award."

Kirkland is Proud Sponsor of Paul Robeson Conference and Alumni Gala

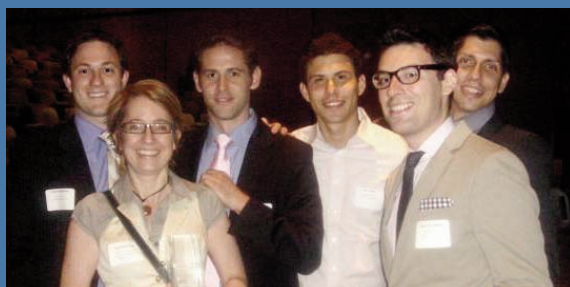

SEO Panel and Reception: What Does Corporate Practice Really Mean?

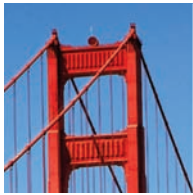

Immigration Equality Recognizes Kirkland with Safe Haven Pro Bono Award

Immigration Equality awarded Kirkland the 2010 Safe Haven Pro Bono Award at the Safe Haven Awards in New York. Given to only five firms out of the 40 participating in Immigration Equality's Pro Bono Asylum Program, the award recognizes law firms that have gone above and beyond to win refuge for lesbian, gay, bisexual, transgender and HIV-positive asylum seekers. Together, these 40 firms donated more than \$14 million in legal services to Immigration Equality clients — winning 76 asylum cases in 2009 — a 99 percent success rate.

NALP/Street Law Legal Diversity Pipeline Program Attracts High School Students to Law

This spring, more than 30 San Francisco attorneys, staff and University of California, Berkeley, Boalt Hall School of Law students volunteered for the NALP/Street Law Diversity Pipeline Program. The program is designed to address the lack of diversity in the legal profession by providing high school students with career pathway education, role models, social support and a chance to experience career-related tasks. This year’s two participating San Francisco high schools have diverse populations greater than 85 percent and graduation rates of 95 percent. Volunteers taught four high school classes lessons in immigration law, contract law and intellectual property law.



Paul Tanaka works with students on a mock negotiation

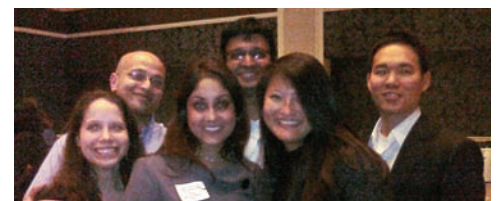
During the second part of the program, nearly 40 high school students visited Kirkland’s San Francisco office for the day. Kirkland attorneys including litigation partner Elizabeth Deeley, and associates John Reinsch (corporate), Kathryn Schubert (corporate), Jasmine Singh (litigation), Kenneth Jenq (IP) and Paul Tanaka (environmental), led three interactive workshops for the students: a mock asylum hearing, mock negotiation and mock trial. After the workshops, the students joined Kirkland attorneys, staff and UC Berkeley law students for lunch and networking.

Jasmine Singh participated for the second year and called the program “eye opening, inspiring and motivational,” because it provides students with an opportunity to interact with attorneys and gain exposure to the legal industry. She worked with the students to discuss different scenarios related to visas and amnesty. What Singh most enjoyed about the program was the students’ thoughts on the fairness of laws regarding immigration, as well as their opinions on how the laws can be changed for the better.

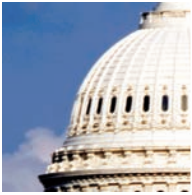

Women Litigators and Juror Perceptions

On March 18, the WLI presented “JuryScope: Women Litigators and Juror Perceptions” for Kirkland women. This audio webinar presentation was broadcast to the attorneys in the Washington, D.C. office. Pulling data from studies of how jurors perceive female litigators, the presentation addressed unique challenges that women advocates face in the courtroom.

Karen McCartan DeSantis, a litigation partner and co-chair of Washington’s WLI, coordinated this unique and intriguing JuryScope presentation. DeSantis wanted to share the presentation with the women because, “For many years, we have heard opinions about perceptions of women in the courtroom. Yet, there is little research that shows that juries, and perhaps judges, assess female advocates differently than male advocates. JuryScope offered data—not just opinion.” DeSantis and others in Washington plan to follow future research on the topic of jury perceptions of women advocates and to present relevant information to Kirkland’s women attorneys.

Kirkland Sponsors Williams Institute Spring Reception

The Williams Institute, a think-tank at the University of California, Los Angeles School of Law, held its spring Washington, D.C.-area reception on May 26 at the Canadian Embassy.

The reception began with a CLE program entitled “Ending Employment Discrimination: ENDA, DADT and the Federal Civil Service.” After the program, guests mingled at a cocktail reception at which U.S. Rep. Tammy Baldwin (D-Wis.) gave remarks on her work to end discrimination against sexual minorities in federal civil service.

The public policy studies, law review articles, amicus briefs and expert testimony provided by The Williams Institute have been widely cited in the national media.

Not only does Kirkland’s involvement increase awareness of The Williams Institute and bring together attorneys from across many different firms, employers and organizations, says Jason Parish, a litigation associate who also attended the event, but it also builds on Kirkland’s reputation as a great work environment for LGBT professionals.
