## Lavender Law Conference & Career Fair

Each year, Kirkland's LGBT attorneys from around the globe gather at the National LGBT Bar Association's Lavender Law Conference. In 2017, Kirkland lawyers gathered in San Francisco to attend the conference and events organized by Kirkland to coincide with the conference, including a Firmwide LGBT Affinity Group workshop, client networking reception and LGBT Affinity Group dinner.

Ten Kirkland attorneys have been named to the National LGBT Bar Association's Best LGBT Lawyers Under 40 list. Kirkland attorneys also sit on the boards and leadership councils of leading LGBT advocacy groups, including Lambda Legal, the National Center for Lesbian Rights and The Williams Institute.

# Moot Court Sponsorships

The Williams Institute annually hosts the only moot court competition focused exclusively on sexual orientation and gender identity law. Kirkland has sponsored law student teams from UC Berkeley, UCLA, Columbia, George Washington University, Georgetown, Harvard, Michigan, NYU, Northwestern, Penn, USC and the University of Texas to participate in the competition. The Firm mentors these students by inviting them to Kirkland's offices for a moot with attorneys in advance of the tournament. Kirkland also provides students a stipend for travel to and from the tournament in Los Angeles.

Law Student Groups
As part of Kirkland's awardwinning ALLSA initiative, Firm attorney liaisons coordinate with 16 LGBT student groups at law schools around the country. The ALLSA initiative has a dedicated budget and offers support for each group ranging from networking events to more substantive study skills, résumé review, interview training, moot court and career development programs.

Hours

Kirkland's attorneys dedicated more than 9,700 hours to LGBT-focused pro bono work in 2017. This work includes a case in federal

court challenging the 2017 Presidential Memorandum excluding transgender individuals from the military. In 2017, the Firm assisted 20 LGBT individuals who were fleeing persecution in their home countries in obtaining asylum in the United States.
