Kirkland & Ellis LLP Forms Women's Leadership Initiative

The Firm recently created the Kirkland & Ellis LLP Women's Leadership Initiative ("WLI"). The goal of the WLI is to provide a forum for discussion of issues that are relevant to women in the Firm and legal community, foster opportunities, and provide a supportive network for our female attorneys. The WLI's inaugural event was held on Thursday, January 22, 2004 in the Chicago office. A training seminar, which was lead by and commenced with a speech from Litigation partner, Emily Nicklin, focused on a discussion of issues in the practice of law that are unique to, or more relevant for women. Jane DiRenzo Pigott, Managing Director, Fuse³ Group LLC, delivered a presentation titled, "The Rules of the Came." Ms. Pigott then engaged Kirkland's Chicago senior women partners in a question and answer session during which the partners relayed experiences, insights, and opinions about their careers and career progression at the Firm. The evening agenda continued at Spiaggia restaurant, beginning with a networking opportunity for our attorneys with a number of our women clients, and concluding with a dinner presentation by Ms. Pigott on mentoring.

The San Francisco office hosted a similar talk by Emily Nicklin on February 9th, the Washington office will host its inaugural WLI event on April 13th, and the New York office is scheduling an event this summer. The women partners in the Los Angeles office will host the Professional Women's Luncheon for women clients this fall.

The Chicago office hosted the second WLI event on March 24, 2004, during which "Practical Tips for Business Development" was presented by Corporate partner, Margaret A. Gibson, Chief Marketing Officer, Karen L. Braun, and Julie Paradise, President, Communication Strategies Company. This event was moderated by Corporate partner, Linda K. Myers, and included a panel discussion on business development by Employee Benefits partner, Vicki V. Hood, Litigation partner, Leslie M. Smith, and Intellectual Property partner, Linda S. Resh. The evening culminated in an opportunity to socialize during a wine and cheese tasting.
